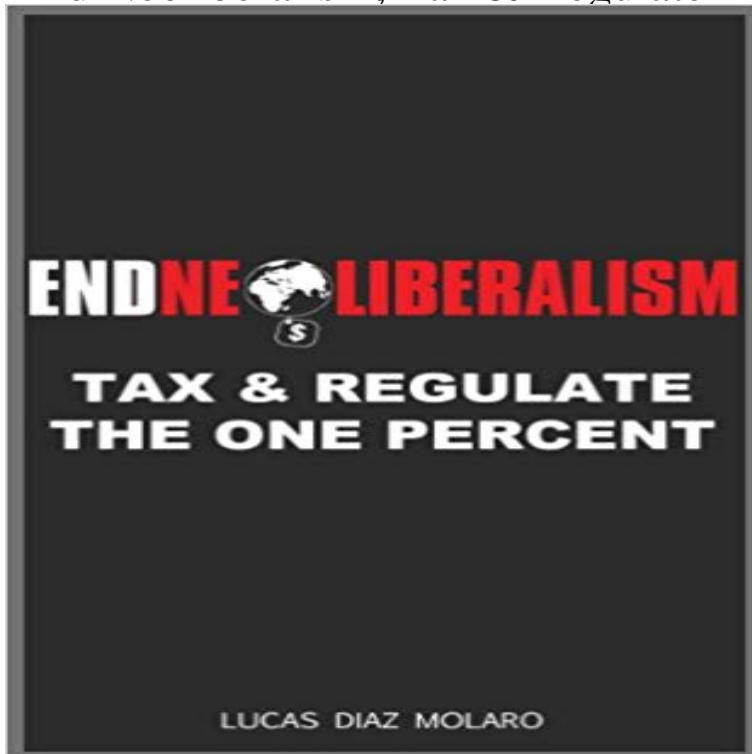


## End Neoliberalism, Tax & Regulate The One Percent

Even if some business leaders wanted to do good, the legal and economic framework forces businesses to take advantage of an economic equilibrium that prices resources and labour too cheap to discard. This is the economic equilibrium left by decades of military and IMF interventions. HOW DO WE END NEOLIBERALISM? Prices need to reflect externalities and government must use its power to tax, regulate, and spend to foster an economic equilibrium that motivates businesses to produce real value. It is possible to have a peaceful and prosperous global economy. Entrepreneurs worldwide are coming up with some of the greatest innovations known to men that can push our economic potential while allowing us to live in harmony with the planet and ourselves. Unfortunately, these innovations cannot compete in a market where profitable corporations continue to be subsidized with trillions of dollars and military power.
