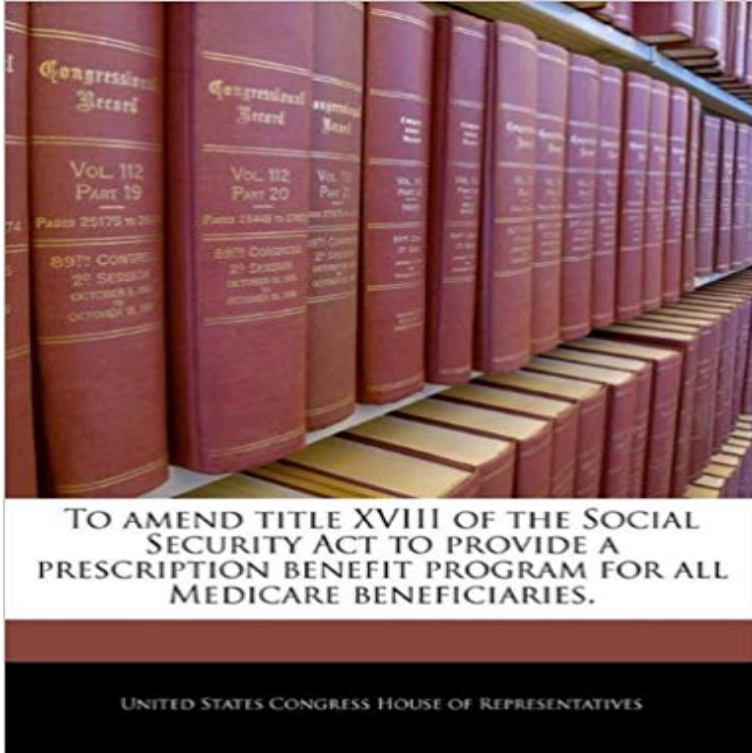


## To amend title XVIII of the Social Security Act to provide a prescription benefit program for all Medicare beneficiaries.
